BYLAE

PRYSHANDHAWING TEN OPSIGTE VAN PETROL

Woordomskrywing

- In hierdie Regulasies, tensy uit die samehang anders blyk, beteken—
"voordeel"—
 - enige geld, artikel, diens of begunstiging wat 'n handelswaarde het; of
 - enige voorwerp hoegenaamd wat, of alleen of tesame met 'n ander voorwerp of met die verrigting van 'n handeling, aan die ontvanger daarvan die reg verleen of heet te verleen om sodanige geld, artikel, diens of begunstiging te ontvang, of om aan 'n kompetisie deel te neem;
en het enige ander woord of uitdrukking waaraan 'n betekenis in die Wet op Petroleumprodukte, 1977 (Wet 120 van 1977), geheg word, daardie betekenis.
- Niemand aan wie die prys waarteen petrol by 'n verspreidingspunt deur sodanige persoon verkoop mag word by regulasie of kennisgewing ingevolge die Wet op Petroleumprodukte, 1977, voorgeskryf is, mag—
 - petrol voorsien of aanbied om petrol te voorsien anders as by wyse van 'n verkoping vir 'n algeheel geldelike teenprestasie en teen die prys aldus voorgeskryf;

No. R. 1100 2 June 1986
REGULATIONS UNDER THE PETROLEUM
PRODUCTS ACT, 1977

Under the powers vested in me by section 2 (1) (d) of the Petroleum Products Act, 1977 (Act 120 of 1977), I, Daniel Wynand Steyn, Minister of Mineral and Energy Affairs, hereby make the regulations in the Schedule hereto.

SCHEDULE

PRICE MAINTENANCE IN RESPECT OF PETROL

Definitions

- In these Regulations, unless the context indicates otherwise—
"benefit" means—
 - any money, article, service or concession having a commercial value; or
 - anything whatsoever which, either by itself or in conjunction with any other thing or with the performance of any act, entitles or purports to entitle the recipient thereof to receive such money, article, service or concession, or to participate in any competition;
and any other word or expression to which a meaning has been assigned in the Petroleum Products Act, 1977 (Act 120 of 1977), shall bear such meaning.
- No person, in respect of whom the price at which petrol may be sold by that person at an outlet may have been prescribed by regulation or notice under the Petroleum Products Act, 1977—
 - shall supply or offer to supply petrol at that outlet other than by way of sale for a wholly monetary consideration and at the price so prescribed;

3. Die Regulasies met betrekking tot Petroleumprodukte, afgekondig by Goewermentskennisgewing R. 2686 van 27 November 1985, word hierby herroep.

(b) shall, as a condition of or as a result of any sale of petrol by a business or undertaking conducted at that outlet, give or offer any benefit to any consumer.

3. The Regulations in respect of Petroleum Products, promulgated under Government Notice R. 2686 of 27 November 1985, are hereby repealed.
